
SHOW CAUSE NOTICE

Sub: - Notice under Rule 12 (2) of CCS (Leave) Rules - regarding.

Whereas Smt. Jyoti Sharma, TGT (English) is unauthorisedly absent from duty at Jawahar Navodaya Vidyalaya, Kaulan Dist Ambala (Haryana) with effect from 11.12.2017 without getting her leave sanctioned.

Whereas, therefore, she have been on EOL for a continuous period exceeding five years. As such, in terms of sub rule (2) of Rule 12 of the CCS (Leave) Rules, 1972, she appear to have deemed resigned from the Samiti Services w.e.f. 11.12.2017.
