Sir/Madam,

With reference to the subject cited above, it is informed by NVS Hqrs that Samiti is actively considering to effect transfers in Annual Transfer Driver 2017 through a system of automation. It is likely to begin from February 2017. A copy of the notice has already been displayed on the website of the Samiti for ready reference. There will be a provision for submission of ONLINE application exercising multiple choice places for transfer by the applicant.

The process of effecting transfer through a software programme is likely to begin in the month of February 2017. For this purpose availability of accurate vacancy position (Actual Vacancy/Deemed Vacancy) in respect of the each posts right from Principal to Multi Tasking Staff (Group "D") is very essential.

In view of the above and guidelines given therein a tentative vacancy position as per the details given below have been worked out on the basis of the records available at Regional Office Level.

- Actual Vacancy Position
- Deemed Vacancy Position
- Vacancies accord due to retirement of the employee (DFR)

The normal tenure of stay at particular station prescribed for certain posts in the Vidyalaya will be as specified below.

S. No.	Post	Normal tenure prescribed at one station (in years)
1	Principal / Vice Principal	05 years (03 years in case of hard & North East Region)
2	PGT/TGT/Misc. Teachers	10 years (03 years in case of hard & North East Region. 02 years for very hard & difficult station)
3	Office Superintendent	05 years (03 years in case of hard & North East Region)
4	Staff Nurse, Catering Assistant, UDC, LDC/Store Keeper	10 years (03 years in case of hard & North East Region. 02 years for very hard & difficult station))
5	The normal tenure below the post of Store Keeper may also be assumed 10 years stay at a post in a particular station.	

You are therefore requested to go through the vacancy position assessed by this office & verify from the records maintained at Vidyalaya Level, keeping in view the guidelines available in the transfer policy.

Since this is a time bound and online exercise, hence personal attention should be given and confirm the correctness of the data by returned of Mail latest by 30th of this Month failing which it will be presumed that the information assessed is correct and the same will be communicated to NVS (Hqrs.) for further necessary action. Please note that no further amendment in the data already uploaded will be made letter date.
